### **OUR MISSION**

To create places and spaces where adults with intellectual and developmental disabilities (I/DD) live, work, learn, and thrive as part of the greater community.

## **OUR VISION**

A world where people of all abilities are welcomed, empowered, and valued.



## **OUR VALUES**

- We believe that people with I/DD have the right to make their own informed choices about their own lives, including where to live and how to live.
- We value the input of people with I/DD to guide the design of programs, activities, and residential communities.
- We believe in the power of developing both the independence and interdependence of adults with I/DD within their communities.
- We value, celebrate, and embrace our shared humanity, individuality, and diversity.
- We respect human relationships, foster inclusion, build collaborative partnerships, and lead with integrity and optimism.
- We believe everyone deserves equal access to opportunities to live a meaningful and connected life regardless of their race, religion, ethnicity, sex, sexual orientation, gender identity, or ability.
- We believe in everyone's ability to reach their **full potential**.

We co-develop a variety of affordable housing communities so that people with I/DD have a choice about where they want to live.

We offer **independent and interdependent living environments**, which are consumer-driven residential communities where people with I/DD bring their own support and services to live in the manner in which they choose.

In the **pre-development stages** of developing a new residential community we:

- Rally support from elected officials and the public.
- Amplify the need for affordable residential communities through constituent engagement by requesting letters and public comments to build enthusiasm for our proposed projects.
- Provide an independent living transition education program for parents, caregivers, and prospective residents.

We are not property managers. We **work in collaboration with property managers** who provide on-site property support to the residential communities where we provide programs and activities.

We offer **fee-for-service consulting** for parent groups or developers aspiring to develop housing or programs for people with I/DD.

# We provide organized programs and activities that support independence and interdependence.

In the **post-development stages** of a new residential community we:

- Provide programs and activities related to community life for residents.
- Create programs that invite and welcome the broader community to further inclusion (e.g., life skills training, cooking classes, health education, and fitness classes).

We are not a direct support provider, and we are not a day program provider. We ask residents to **work with their local Regional Center to connect with the support they need** to live independently. We invite day program providers to participate in our programmatic offerings.

#### We are a facilitator and a guide.

 Our programs and activities support people with I/DD to independently form relationships, connect with each other, and initiate their own connections in the community.

We also **provide programs that are not associated with the residential communities**, including programs at the Sunflower Hill Garden in Livermore, virtual cooking classes, and social engagement classes.

*Given our focus on affordable housing, we do not accept private investments in exchange for guaranteed units.* 







# STRATEGIC PRIORITIES AND GOALS



Strategic Priority 1: Develop inclusive affordable housing communities.

**Goal:** Co-develop three new projects in the next 5 years with a goal of 100 units of affordable housing for adults with I/DD.

Strategic Priority 2: Create and implement multidisciplinary transition training and independent and interdependent living programs

**Goal:** Equip adults with I/DD, their families, and caregivers with the information and tools necessary to successfully transition to independent and interdependent living. Strategic Priority 3: Create clear and accessible language about who we are and all that we offer for our constituents.

**Goal:** All constituents, including residents, program participants and their families, supporters, developers, and other partners, understand who we are and what we offer.
